BASCA Commission Fee Survey 2011: The Results

1. Overview

BASCA commissioned a survey into the fees charged by composers, publishers and commissioners for musical compositions across a multiple range of instrumentations and genres, both inside and outside UK.

This survey was undertaken between 8th December 2010 and 9th March 2011, and covered a time period for commissions carried out between January 2005 and December 2009 (five years). The survey data was broken down by the involvement of the interested party (composer, publisher or commissioner).

In total, 522 responses were received. Five responses have been excluded from costs analysis due to zero values, resulting in 517 actual responses that form the basis of the whole data analysis. This is further explained later in this document.

This document describes the results of the findings from the survey, and identifies salient points relating to the data received.

The overall breakdown of respondents by involvement was as follows:




Figure 1 - Summary by Involvement




2. Management Summary

This section describes the summarised findings of the survey results. Detailed analysis follows in Section 3 – Detailed Analysis.

Breakdown by Instrumentation and Genre - Number of Responses

The chart below indicates the number of responses from each respondent relating to instrumentations and genre, sorted in descending order of number of responses.



The average number of responses per category was 29, with a total sample of 522 responses, with five excluded (zero values).

The category "Accompanied Choral" received the most responses at 54.

The category with the fewest responses was "Electronica (C)" with 2 responses.



Breakdown of Category - Total Value

The chart below indicates the total value of commissions, by Category, in descending order of value.




Figure 2 - Breakdown of Total Value by Category

The total value of all commissions in the survey time period was £2.9million (excluding VAT). The total average per category was £162,308. This is not a statistical "weighted" average (i.e. no allowance has been made for the number of commissions per category, only the total of commission fees for each category has been analysed for this section). The total fee per category is shown in more detail in the table below:

Location of Commission

The pie chart below shows the proportion of works commissioned within the UK, compared with those commissioned outside the UK.




Figure 3 - Location of Commissions

The majority of commissions (83% - 431) were for UK, with 17% (91) commissioned outside of the UK. This chart shows ALL responses, including zeroes.

However, although the majority of commissions occurred within the UK, the value of the commissions by location indicates that overseas commissions have a far greater value. The table below details the value data that supports this:

The number of overseas commissions amount to 17% of the total (91 responses from 522), but the value for overseas is 32% of the total declared values (£949,302 from £2.9million).

The average UK commission (weighted; i.e. the number of commissions per category is taken into account) was £4,579 per commission.

The average Non-UK commission (weighted; i.e. the number of commissions per category is taken into account) was £10,431 per commission.

Overseas commissions are therefore recorded as being over 2.25 times more valuable that UK commissions. This information is broken down in more detail in Section 3.



3. Detailed Analysis

This section provides further analysis into the data received for all commissions and, where appropriate, displays the long tail data for specific categories.

Total Fees versus Commission Costs per Minute

The commissions ranged in duration from 30 seconds to 624 minutes (10:24).

If all commissions were of equal length, then comparisons between each can be made based solely upon total value, but the wide variety of durations may serve to skew the total values per commission, so analysis has been performed on a "cost per minute" basis in this section.

The table below details the average cost per minute of each commission, by category, and identifies the highest and lowest costs per minute of each.

It can be seen that the highest value category in terms of average cost per minute is "Electronica (C)" at £742.05 per minute, and the least is "Jazz Big Band" at £135.49 per minute.

The category that produces the highest cost per minute overall is "Symphony Orchestra" at £2021.30 per minute. The genre with the lowest cost per minute overall is "Accompanied Choral" at £0.50



There were 5 commissions reported as having a fee of £0.00, but these have been omitted from the survey results as these can be considered "gifts" as opposed to formal commissions, and the zero values would only serve to distort the average data unnecessarily.

Of the zero values, two were from "Solo", two from "Duo", and one from "Symphony Orchestra".

The table below shows the same breakdown of data as shown in the previous table, but this time it focuses on duration, as opposed to average cost per minute.

The category with the longest duration on average is "Electronica (A)" at 85.4 minutes. The category with the lowest average duration is "Unaccompanied Choral" at 8.2 minutes.

Of the overall total, the category "Electronica (A)" had the longest maximum duration at 624 minutes, and the category "Solo" had the shortest recorded duration of 30 seconds.



Breakdown of Total and Average Fees by Location of Commission

The table below indicates the weighted average (total divided by number of respondents per genre) for each commission taken within UK or outside of UK.

The main area of note is that overseas commissions are, on average, at least twice as valuable as UK commissions - £10,548 average for Non-UK compared with £4,626 average for UK. This report does not investigate why this may be the case.



Long Tail Analysis - Total Fees

This section examines the distribution of the total fees across all categories against a statistically perfect "model" distribution. It breaks down each fee into a logarithmic "bin", resulting in something called a Log Normal Distribution.

All data, irrespective of the source or nature, will generally follow a "Gaussian Distribution", or bell-curve, shown below:




Figure 4 - Typical Bell Curve or "Gaussian" Distribution

The above example shows how a normal distribution occurs. This states that for many occurrences of data (e.g. IQ or Height), the results tend to be centred on the average, and for the extremes, the data sharply falls. This model applies to most data structures. For the survey results, the resultant data was modelled in accordance with a "Normal" distribution. If the curve from the survey fee analysis matches that above, then we can state that the data is fairly and uniformly distributed. If it veers to the left, then it indicates a tendency toward low monetary values per commission (when compared to the "norm"), and if it veers to the right, then it indicates higher values compared to the "norm". For this analysis, the profile of the resulting curve was examined in detail and all supporting data is shown below.



Fee Commission Survey Long Tail

The chart below shows the "long tail" for each logarithmic group of fees charged.




Figure 5 - All Categories Long Tail


Explanation for Data

Total Commission Fees with a value of between £0 and £1.00 will be counted and placed within Group 1, those with ranges of £2.00-£3.00 will be in Group 2, up to Group 19 which counts fees in the range £31,623 and £56,234, and Group 20 which counts fees in ranges £56,234 to £100,000. In Group 20, one commission had a value of £78,000. In Group 12, 26 commissions between values of £562 and £1000 in total amounted to a total value for that group of £19,056.

Long Tail Analysis

The long tail for Total Fees shows a skew to the right. This means that of the responses received, it is more heavily clustered around higher value commissions. This is to be expected for a survey that has a population solely of professional composers, publishers and commissioners. If the whole UK was taken for example, it is possible we would see a far greater proportion of lower value or free commissions. This shows that the results are skewed overall to high value responses.

Variance per Group



The above chart shows by how much each group deviates from the "model" (i.e. best fit). This example from the survey indicates that for the upper-mid range values (groups 17 to 19), there are too many occurrences. For the highest group (20), the chart shows that there are too few occurrences. One would expect to see higher value commissions in the range £56K to £100K. This indicates that the premium value commissions are not charging as much money as they could (or should), and it indicates a "squeeze" toward the middle, i.e. commissions are being de-valued in the market.



4. Further Sub-Category Analysis

This section focuses upon the top six categories, ranked by number of responses, and charts the Log Normal data profiles for these specific categories of commission. Due to the number of responses per category being much less than the total (around 10% for each of the top 6), the profiles tend to "fragment" when compared to profiles using large data sets (500 +). Nevertheless, certain data characteristics can still be ascertained from each profile.

Categories Ranked by Response

The table below identifies the responses per category, and highlights the top 6 that have log normal profiles charted on the following pages.

Summary


In all charts, the skew is heavily toward the right, indicating that the responses have been drawn from the higher fee earners from the entire sample. This is expected as the sample focussed on professional parties only.

The two categories of Large Chamber Ensemble and Small Chamber Ensemble display the "feature" that has been seen in all categories, inasmuch as the expected top group of fees are underperforming, and we can see that these fees have been pushed into lower categories – noted by the two spikes in these charts.





Small Chamber Ensemble


BASCA Commission Fee Survey - Small Chamber Ensemble Log Normal Distribution








BASCA Commission Fee Survey - Solo Log Normal Distribution
